Valuation for Traditional Retail Replacement

Item 1

One, lady's, hand-finished raised, 18ct white gold and diamond set, three stone ring. Plain, narrow, low half round, tapered band, measures 2.45mm width (at base) x 1.12mm depth, tapers up to 4.64mm width (at top), with cut-out underrail, underneath.

Feature "trilogy style" ring design, comprising raised channel setting, across the top of the band, housing three round brilliant cut diamonds, channel set. The extended shoulders, fluted towards the top.

Polished finish, stamped "18CT" 3.4.5. L- B - acid tested as 18 carat gold.

Finger size = P.

The ring contains;

Three channel set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Dimensions = 3.60mm (Diameter) x 2.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 4.60 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
