One, hand-assembled, 9ct white gold, articulated, diamond set bracelet.

Feature articulated, 'line' style bracelet design, consisting of individual, open back, four claw railed settings, each housing one round brilliant cut diamond, claw set.

Press style, 'box' type clasp attached, with two 'figure 8' safety catches fitted.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Bracelet dimensions = 19.50cm (length including clasp) x 2.93mm (ave. width) x 3.08mm (ave. depth).

The bracelet contains:

Sixty Five claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H & brown tint' (mixed).
Dimensions (average) = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 1.00ct (estimated - see NOTE below)

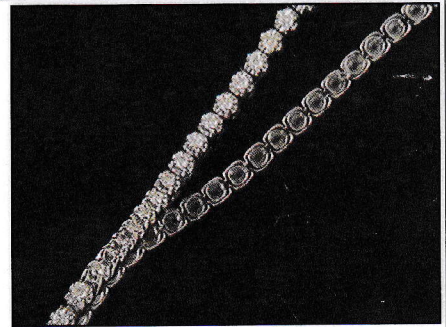
Total Item Weight = 10.06 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 9.86 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
