Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 10ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, narrow band of 1.34mm in width (at base) x 1.48mm depth.

Feature 'tear-drop' shape design setting, housing a total of thirty-one factory grown synthetic diamonds, tapering in size, claw set. Three prong base support, all secured to the top of the plain and polished band.

Polished finish.

Stamped '10K MHJ 48JO280927 0.40TDW LGD' - acid tested as approximately 10 carat gold. Finger size is O.

The ring contains:

Thirty One claw set round brilliant cut laboratory grown synthetic diamonds, clarity 'Si', colour 'H'.

Dimensions = 1.20mm - 1.90mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 2.38 grams

Total Gemstone Weight = 0.40ct

Total Metal Weight = 2.30 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the factory grown synthetic diamonds cannot be ascertained. Therefore, weights of the factory grown synthetic diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the factory grown synthetic diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
