Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 9ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.94mm width (at base) x 0.68mm depth, with a curved underrail.

Feature three white gold illusion plates, within a decorative six claw setting, graduating in size, largest to the centre. Each housing one round diamond, claw set. The settings are secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped 'Duffs 750' - acid tested as 18 carat gold and 9 carat gold.

Ring size: Q 1/2.

The ring contains:

Two claw set old cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.68mm(L) x 2.65mm(W) x 1.62mm(D-estimated) (smallest)

Dimensions = 3.50mm(L) x 3.47mm(W) x 2.12mm(D-estimated) (largest)

Total Weight = 0.23ct (estimated - see NOTE below)

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 2.72mm(Dia) x 1.66mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 4.16 grams Total Gemstone Weight = 0.30ct Total Metal Weight = 4.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
