One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, flat band of 2.69mm width (at base) x 1.99mm depth, with open back settings.

Feature one row of forty round brilliant cut diamonds, running around the entire circumference of the band, varying slightly in size, and channel set.

Polished finish.

Stamped '18K 0.60' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

Forty channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 2.84 grams

Total Gemstone Weight = 0.60ct

Total Metal Weight = 2.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
