Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is joined on both sides to a 'trace' style link chain, that has been finished with a 'parrot' style clasp.

Necklet dimensions = 39.50cm (ave. length) x 1.5mm (ave. width).

Pendant dimensions = 5.49mm (ave. length) x 5.46mm (ave. width) x 3.76mm (ave. depth).

Polished finish.

Stamped '375 T unknown symbol d' - acid tested as 9 carat gold.

The necklet contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "L".
Dimensions = 5.30mm(Dia) x 3.26mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.57ct (estimated - see NOTE below)

Total Item Weight = 3.04 grams
Total Gemstone Weight = 0.57ct
Total Metal Weight = 2.93 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
