### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, 'solitaire' design, diamond set ring, of cast construction.

Plain, narrow, tapered band of 1.36mm in width (at base) x 0.74mm depth.

Feature 'solitaire' style ring design, consisting of a six claw railed setting, housing one round brilliant cut diamond, claw set. All secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'AG' - acid tested as 18 carat gold.

Finger size is G.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'G'.

Dimensions = 3.83mm(L) x 3.79mm(W) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 1.89 grams

Total Gemstone Weight = 0.21ct

Total Metal Weight = 1.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
