Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, platinum, gem set, stud earrings, of hand-assembled construction.

Feature 'cluster' style earrings with a central three claw setting, housing one trilliant cut synthetic spinel, claw set. Surrounding is one row of twenty-four round brilliant cut diamonds, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 9.48mm (ave. length) x 9.42mm (ave. width) x 6.24mm (ave. depth).

Polished finish.

Stamped 'PT950' - acid tested as platinum and 14 carat gold(butterflies).

The earrings contain:

Two claw set trilliant cut synthetic spinels, colour is "blue".

Dimensions = 7.15mm(L) x 7.15mm(W) x 4.30mm(D-estimated)

Total Weight = 2.88ct (estimated - see NOTE below)

Forty Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 4.08 grams Total Gemstone Weight = 3.12ct Total Metal Weight = 3.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
