Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 18ct white gold & gemset, cluster dress ring. Plain, narrow, low half round, tapered band, measures, 2.54mm width (at base) x 1.07mm depth, with cut-out underrail, open back settings, underneath.

Feature; "cluster style" design & shoulder stones. Comprising, a four claw setting, houses one oval-shaped, faceted, natural sapphire, claw set. Drops to a surround, contains ten round brilliant cut diamond, claw set, The extended shoulders, of the band tapers up to the top, each shoulder contains five round brilliant cut diamonds, channel set.

Polished finish, stamped "18K (faint) - acid tested as 18 carat gold. Finger size = K1/2.

The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "medium - pink".

Dimensions = 5.73mm (L) x 4.37mm (W) x 3.10mm (D-estimated)

Total Weight = 0.63ct (estimated - see NOTE below).

Twenty claw set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (smallest)

Dimensions = 2.01mm (average diameter) x 1.23mm (D-estimated) (largest)

Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 3.68 grams, Total Gemstone Weight = 1.23ct, Total Metal Weight = 3.43 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
