### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow knife-edge band of 1.84mm width (at base) x 0.95mm depth, with a hollow top and shoulders.

Feature platinum, 'solitaire' style ring design, consisting of a four claw setting, housing one round brilliant cut diamond, claw set. Secured between the knife-edge shoulders of the plain and polished band.

Polished finish.

Stamped 'DOM 950 950' - Assayed in Birmingham, England - acid tested as platinum.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 5.77mm(L) x 5.75mm(W) x 3.45mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.71ct (estimated - see NOTE below)

Total Item Weight = 2.66 grams

Total Gemstone Weight = 0.71ct

Total Metal Weight = 2.52 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
