Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.74mm width (at base) x 1.15mm depth, with open back settings, and a curved underrail.

Feature central bezel setting, housing one oval natural sapphire, bezel set. Surrounding is one row of fourteen single cut diamonds, creating a 'scalloped' style edge, varying slightly in size, and claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One bezel set oval shaped natural sapphire, colour is "black".

Dimensions = 8.00mm(L) x 5.75mm(W) x 3.98mm(D-estimated) x 5%(Bulge)

Total Weight = 1.60ct (estimated - see NOTE below)

Fourteen bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.20mm - 1.30mm(diameter)

Total Weight = 0.13ct (estimated - see NOTE below)

Total Item Weight = 3.16 grams Total Gemstone Weight = 1.73ct Total Metal Weight = 2.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
