Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, gem set, dress style ring, of cast construction.

Plain, narrow, tapered band of 8.85mm at top to 2.82mm in width (at base) x 0.65mm depth, with hollow top and shoulders, and open back settings.

Feature oval cut and faceted natural sapphire, rub-over set to the top of the plain and polished, hollow style band.

Polished finish - stamped '14K' - acid tested as 14 carat gold. Finger size is Q 1/2.



The ring contains:

One rub over set mixed cut oval cut and faceted natural sapphire, colour 'medium blue'.

Dimensions = 6.93mm(L) x 6.05mm(W) x 4.11mm(D-estimated)
Total Weight = 1.50ct (estimated - see NOTE below)

Two gypsy set round brilliant cut diamonds, clarity 'Vs', colour 'I to J' (mixed).

Dimensions (average) = 2.22mm(Dia) x 1.35mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 4.68 grams - Total Gemstone Weight = 1.58ct - Total Metal Weight = 4.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
