Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.52mm width (at base) x 0.91mm depth, with open back settings.

Feature central white gold panel, housing two rows of ten round brilliant cut diamonds, graduating in size, largest to the centre, and claw set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: N 1/2.

The ring contains:

Twenty claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed).
Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.35mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.84ct (estimated - see NOTE below)

Total Item Weight = 3.33 grams
Total Gemstone Weight = 0.84ct
Total Metal Weight = 3.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
