Fabricated from 9 carat yellow gold.

Of a 'curb' style linkage design.

Linkage of solid construction.

Extra large engraved 'padlock' style clasp attached.

Safety chain fitted.

Ring style end link sections.

Polished finish.

Stamped '375 AC'.

Acid tested as 9 carat gold.

Bracelet dimensions = 20.00cm (length including clasp) x 9.68mm (ave. width) x 5.07mm (ave. depth).

Padlock dimensions = 26.00mm (length including arm) x 18.36mm (width) x 4.29mm (depth).

Total Item Weight = 53.42 grams.
