### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.56mm width (at base) x 1.02mm depth.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. Each of the tapering shoulders, is embellished with a triangular curved white gold shoulder plates, and one single cut diamond, bead set. The setting and the shoulder plates are secured to the top of the plain and polished yellow gold band.

Polished finish.

Stamped 'METEOR 18CT PALL' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "G".

Dimensions = 4.95mm(L) x 4.93mm(W) x 3.25mm(D-estimated) x 1.5%(Girdle Thickness)

Total Weight = 0.49ct (estimated - see NOTE below)

Two bead set round brilliant cut diamonds, clarity is "Vs", colour is "H to I" (mixed).

Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 3.73 grams Total Gemstone Weight = 0.52ct Total Metal Weight = 3.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
