Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold and 14ct rose gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.17mm width (at base) x 1.18mm depth, with a curved underrail.

Feature central railed rose gold four claw setting, housing one cushion cut synthetic moissanite, claw set. Either side of the central setting, is one three claw setting, each housing one pear shaped synthetic moissanite, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'SBJ 585' - acid tested as 14 carat gold.

Ring size: K 1/2.

The ring contains:

One claw set rectangular cushion synthetic moissanite, colour is "colourless".

Dimensions = 6.97mm(L) x 5.64mm(W) x 4.18mm(D-estimated)

Total Weight = 1.38ct (estimated - see NOTE below)

Two claw set pear shaped synthetic moissanites, colour is "colourless".

Dimensions (average) = 7.42mm(L) x 4.75mm(W) x 2.90mm(D-estimated)

Total Weight = 1.16ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams Total Gemstone Weight = 2.54ct Total Metal Weight = 2.62 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
