Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.77mm width (at base) x 1.22mm depth, with a hollow top and shoulders, open back settings, and a curved cut out underrail.

Feature cushion shaped top plate, housing one round brilliant cut diamond, to the centre, claw set. Surrounding is three rows of round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the tapering shoulders, of the plain and polished band. Each of the shoulders houses two rows of four round brilliant cut diamonds, graduating in size, claw set. There are a total of sixty-five round brilliant cut diamonds.

Polished finish. Stamped 'SK 14K' - acid tested as 14 carat gold. Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.38mm(Dia) x 2.06mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Forty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.55ct (estimated - see NOTE below)

Twenty Four claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.81mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 6.19 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 5.79 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
