## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 2.81mm width (at base) x 0.91mm depth, a hollow top and shoulders, and open back settings.

Feature central four claw setting, housing one oval natural garnet, claw set. The setting is secured between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished band. One of the shoulder terminations houses twenty-one round brilliant cut diamonds, graduating in size, and bead set.

Polished finish.

Stamped 'unknown symbol K18 0.30' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One claw set oval shaped natural garnet, colour is "red/purple".

Dimensions = 11.79mm(L) x 9.55mm(W) x 5.54mm(D-estimated)

Total Weight = 5.31ct (estimated - see NOTE below)

Twenty One bead set round brilliant cut diamonds, clarity is "Vs", colour is "G".

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 9.03 grams Total Gemstone Weight = 5.60ct Total Metal Weight = 7.91 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
