Valuation for Traditional Retail Insurance Replacement

Item 1

One, 15ct yellow gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 0.72mm width (at base) x 3.17mm depth, with a curved underrail.

Feature central railed four claw setting, housing one emerald cut natural rutilated quartz material, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. Each of the shoulders is embellished with pierced detail.

Polished finish.

Unstamped - acid tested as approximately 15 carat gold.

Ring size: I.

The ring contains:

One claw set emerald cut natural rutilated quartz, colour is "colourless".
Dimensions = 18.11mm(L) x 17.83mm(W) x 8.95mm(D-estimated)
Total Weight = 19.15ct (estimated - see NOTE below)

Total Item Weight = 9.53 grams
Total Gemstone Weight = 19.15ct
Total Metal Weight = 5.70 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
