Linkage of hollow construction.

Extra large heart-shape 'padlock' style clasp attached.

Ring style end link sections.

Safety chain fitted.

Polished finish.

Stamped '9ct'.

Acid tested as 9 carat gold.

Bracelet dimensions = 18.50cm (length including end ring sections) x 19.50mm (max. width).

Padlock dimensions = 39.00mm (length including arm) x 23.00mm (width) x 4.30mm (depth).

Total Item Weight = 49.45 grams.
