Valuation for Traditional Retail Replacement

Item 1

One, lady's, 18ct yellow gold and gemstone set, multistone cluster style ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.86mm width (at base) x 0.66mm depth, with open back.

Feature "cluster style" ring design, comprising nine individual claw settings, each contains one oval-shaped synthetic ruby, claw set. The extended shoulders, taper up to the top, split into five rails, three plain, two rope style, both sides.

Polished finish, stamped "18K" - acid tested as 18 carat gold.

Finger size = R.

The ring contains;

Three claw set oval-shaped, faceted, synthetic rubies, colour is "medium dark - red".

Dimensions = 5.90mm (length) x 4.15mm (width) x 2.53mm (D-estimated)

Total Weight = 1.53ct (estimated - see NOTE below).

Six claw set oval shaped synthetic rubies, colour is "medium dark - red".

Dimensions = 4.80mm (length) x 2.99mm (width) x 1.82mm (D-estimated)

Total Weight = 1.33ct (estimated - see NOTE below).

Total Item Weight = 8.90 grams, Total Gemstone Weight = 2.86ct, Total Metal Weight = 8.33 grams (estimated)

NOTE: limited gemmological testing, inset, identified gemstones as synthetic rubies. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
