Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.11mm width (at base) x 1.35mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature cushion shaped top plate, housing nine round brilliant cut diamonds, to the centre, invisibly and claw set. The surround, gallery and shoulders house a total of seventy-four round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the decorative tapering shoulders, of the plain and polished band. Millegrain detail to the edges of the settings.

Polished finish.

Stamped '10K 1.00 michael hill' - acid tested as approximately 10 carat gold.

Ring size: H.

The ring contains:

One invisibly set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 3.00mm(Dia) x 1.83mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Seventy Four claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.12mm(Dia) x 0.68mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.62mm(Dia) x 1.60mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.89ct (estimated - see NOTE below)

Total Item Weight = 4.66 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
