## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, diamond set, multistone, hinged oval bangle, of hand-assembled construction.

Feature the front panel has three rows, housing a total of eighty-five round brilliant cut diamonds. The central row has larger diamonds, and the two side rows have smaller diamonds, pave set. The hollow style bangle is enclosed with a decorative cut out underrail. The bangle is finished with a box clasp and a figure 8 safety catch.

Bangle dimensions = 64.00mm (ave. length) x 52.00mm (ave. width) x 2.93mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The item contains:

Twenty Nine pave set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.88ct (estimated - see NOTE below)

Fifty Six pave set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.12ct (estimated - see NOTE below)

Total Item Weight = 22.29 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 21.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bangle employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
