### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One pair of, 9ct yellow gold and 9ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature cushion shaped top plate, housing nine white gold illusion settings, and four claw settings, to the centre, each housing one round brilliant cut diamond, illusion and claw set. Surrounding is one row of twenty-eight single cut diamonds, claw set. The earrings have been finished with yellow gold post and butterfly attachments.

Earring dimensions = 11.78mm (ave. length) x 11.61mm (ave. width) x 3.78mm (ave. depth).

Polished finish.

Stamped '9K 0.75CT' - acid tested as 9 carat gold.

The item contains:

Eighty Two illusion and claw set round brilliant cut diamonds, clarity is "P3", colour is "H to J" (mixed).

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 3.82 grams

Total Gemstone Weight = 0.75ct

Total Metal Weight = 3.67 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
