Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.04mm in width (at base) x 1.13mm depth, with open back settings.

Feature two individual 'square-shape' railed settings, each housing one round brilliant cut diamond, claw set. Secured between the 'cross-over' and split shoulders of the plain and polished band. One row each side houses seven round brilliant cut diamonds, tapering in size, bead set.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is N 1/2.

The ring contains:

Two rub over set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H to I' (mixed).
Dimensions = 3.83mm(Dia) x 2.39mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.42ct (estimated - see NOTE below)

Fourteen bead set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to J' (mixed).
Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 4.29 grams - Total Gemstone Weight = 0.62ct - Total Metal Weight = 4.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
