Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.40mm width (at base) x 0.88mm depth, with curved underrail.

Feature; "pyramid style cluster" design. Comprising, a raised four claw setting to top, houses one round brilliant cut diamond, claw set. Drops to a double wire basket surround, contains one round brilliant cut diamond & twenty three single cut diamonds (mixed), claw set. The extended shoulders, of the band tapers upwsept, split end terminations, to both sides.

Polished finish, unstamped - acid tested approximately 18 carat gold. Finger size N1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H/I"(inset), medium cut quality.
Dimensions = 5.85mm (average diameter) x 3.57mm (D-estimated)
Total Weight = 0.75ct (estimated - see NOTE below).

Twenty Four claw set single cut & brilliant cut diamonds (mixed), clarity is "Si", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.60mm (average diameter) (smallest)
Dimensions = 1.93mm (average diameter) (largest)
Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 5.80 grams, Total Gemstone Weight = 1.35ct, Total Metal Weight = 5.53 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
