Valuation for Traditional Retail Replacement

Item 1

One, lady's, raised 18ct white gold, diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.41mm width (at base) x 1.50mm depth, with cut-out underrail, open back settings, underneath.

Feature "single row" style ring design, comprising of a rectangular-shaped top with a channel setting, housing four round brilliant cut diamonds, channel set, The extended shoulders, of the band, both sides taper with a v-shaped groove near the top.

Polished finish, stamped "18K" - acid tested as 18 carat gold.

Finger size = U1/2.

The ring contains;

Four channel set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm (average diameter) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.09ct (estimated - see NOTE below).

Total Item Weight = 5.35 grams, Total Gemstone Weight = 0.09ct, Total Metal Weight = 5.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
