## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct white gold, dress style, gem set ring.

Plain, narrow band of 2.00mm in width (at base) x 2.02mm depth, with closed back settings.

Feature two individual, closed back, 'doughnut' style settings, each housing one round brilliant cut diamond, rub-over set. The settings are secured to the terminations of the band, having an opening to the centre top.

Polished finish.

Stamped '750 GJ 57' - acid tested as 18 carat gold.

Finger size is Q.

The ring contains:

Two rub over set round brilliant cut diamonds, clarity 'Vs', colour 'H to I' (mixed).

Dimensions (average) = 2.95mm(Dia) x 1.80mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 4.27 grams

Total Gemstone Weight = 0.20ct

Total Metal Weight = 4.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
