Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 2.04mm width (at base) x 0.92mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one oval natural sapphires, claw set. Either side of the central setting, is one elliptic shaped setting, housing one single cut diamond, claw set. There are also two four claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured in between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '18K 18CT 6116P' - acid tested as 18 carat gold.

Ring size: V.

The ring contains:

One claw set oval shaped natural sapphire, colour is "blue".

Dimensions = 6.02mm(L) x 5.40mm(W) x 3.37mm(D-estimated)

Total Weight = 0.92ct (estimated - see NOTE below)

Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.11ct (estimated - see NOTE below)

Total Item Weight = 3.16 grams Total Gemstone Weight = 1.03ct Total Metal Weight = 2.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
