Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.94mm width (at base) x 1.36mm depth, with open back settings, and a 'cross over' style underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and square shoulders of the plain and polished band. Each of the shoulders houses one row of seven round brilliant cut diamonds, graduating in size and channel set.

Polished finish.

Stamped 'MHJ 750 1.00' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 5.60mm(L) x 5.59mm(W) x 3.53mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Fourteen channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.92 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 2.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
