Valuation for Traditional Retail Insurance Replacement

Item 1 .

One, lady's, hand-assembled raised, 18ct yellow & white gold, diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, 2.12mm width (at base) x 1.23mm depth, with curved underrail

Feature "solitaire style" ring design, with raised four claw setting of white gold, housing one Princess cut diamond, claw set. The extended shoulders, of the yellow gold band, taper up to pointed end terminations, both sides.

Polished finish, stamped "750.53" - acid tested as 18 carat gold.

Finger size = M1/2.

The ring contains;

One claw set Princess cut diamond, clarity is "Vs2", colour is "H", medium cut quality.
Dimensions = 4.57mm (L) x 4.36mm (W) x 3.10mm (D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.53ct (estimated - see NOTE below).

Total Item Weight = 3.14 grams, Total Gemstone Weight = 0.53ct, Total Metal Weight = 3.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
