Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 9ct yellow and white gold, diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 3.18mm width (at base) x 1.28mm depth, with open back, underneath.

Feature; "cluster style" design, with shoulder stones. Comprising, a raised 3 x tier cluster in white gold, housing, six round brilliant cut diamonds, claw set, to centre top. Drops to a double surround contains twenty five round brilliant cut diamonds & thirty single cut diamonds, bead set. The extended shoulders, of the band sweeps up into three rows each side contains five round brilliant cut diamonds, chanel set, two outer rows contain a total of fourteen round brilliant cut diamonds, bead set both sides.

Polished finish, stamped "375, JP02" - acid tested as 9 carat gold.

Finger size = N1/2.

The ring contains;

Six claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.
Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated)
Total Weight = 0.20ct (estimated - see NOTE below).

Ninety Three bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.
Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)
Total Weight = 0.80ct (estimated - see NOTE below).

Total Item Weight = 5.01 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 4.81 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
