Bangle diameter = 62.00mm (internal diameter) x 6.40mm (ave. width) x 2.40mm (ave. depth).

Polished finish.

Stamped 'WG21K'.

Acid tested as 21 carat gold.

Total Item Weight = 11.24 grams.
