One, hand-assembled, pendant.

Fabricated in 21 carat yellow gold.

Feature closed back, hollow, radiating decorative pendant design.

A medium-sized ring is secured to the centre top.

The pendant is articulated from a plain tapering bail assembly.

Polished finish.

Stamped 'MA 21C'.

Acid tested as 21 carat gold.

Pendant dimensions:

75.50mm (length including bail)

50.00mm (diameter).

Total Item Weight = 14.00 grams.

NOTE: This piece is believed to be of Asian manufacture and would be extremely difficult to replicate in Australia. The replacement figure is therefore based upon procuring from overseas a similar piece, allowing for precious metal content and minimum hours of manufacture.
