Valuation for Traditional Retail Insurance Replacement

One bangle.

Fabricated from 10 carat yellow gold.

Hollow construction.

Of an un-hinged 'slave' design.

Round in shape.

Half round domed, decorative, diamond cut patterned outer top profile.

Bangle dimensions = 65.00mm (internal diameter) x 10.10mm (ave. width) x 0.50mm (ave. depth).

Polished finish.

Stamped '10K AZAD'.

Acid tested as 10 carat gold.

Total Item Weight = 11.60 grams.

NOTE: This piece is believed to be of Asian manufacture and would be extremely difficult to replicate in Australia. The replacement figure is therefore based upon procuring from overseas a similar piece, allowing for precious metal content and minimum hours of manufacture.
