Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.32mm width (at base) x 0.56mm depth, with a curved underrail.

Feature round top plate, within a six claw setting, housing seven round brilliant cut diamonds, varying slightly in size, and claw set. The setting is secured to the underrail, and in between the extended and rounded shoulders, of the plain and polished band. Rhodium plating to the setting areas.

Polished finish.

Stamped '750(faded)' - acid tested as 18 carat gold.

Ring size: I 1/2.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).
Dimensions = 2.66mm - 2.75mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
