Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.83mm width (at base) x 1.22 depth, with a hollow top and shoulders, open back settings, a curved underrail.

Feature round top plate, within a four claw setting, housing thirteen round brilliant cut diamonds, largest to the centre, claw set. The setting is secured to the underrail, and in between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, graduating in size, and channel set.

Polished finish.

Stamped '14K michael hill 0.75 TDW' - acid tested as 14 carat gold.

Ring size: H.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "J".

Dimensions = 3.85mm(Dia) x 2.35mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Twenty Two claw and channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

Total Item Weight = 2.18 grams Total Gemstone Weight = 0.76ct Total Metal Weight = 2.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
