Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.50mm width (at base) x 1.11mm depth, with a curved underrail.

Feature round top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "light tinted brown".

Dimensions = 4.45mm(Dia) x 2.71mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "light tinted brown".

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 2.79 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
