Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gme set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 3.39mm width (at base) x 1.03mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature central square bezel setting, housing four Princess cut diamonds, invisibly set. Surrounding, is one row of twenty round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one inner row of eight baguette cut diamonds, graduating in size, and channel set, and two outer rows of eight round brilliant cut diamonds, claw set. Rhodium plating to the diamond setting areas.

Polished finish. Stamped '750 JP88' - acid tested as 18 carat gold. Ring size: O 1/2.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "P1", colour is "I".

Dimensions = 2.30mm(L) x 2.30mm(W) x 1.63mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Fifty Two claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Sixteen channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions = 2.00mm(L) x 1.20mm(W) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(L) x 1.40mm(W) x 1.02mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 5.92 grams Total Gemstone Weight = 1.14ct Total Metal Weight = 5.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
