One, hand assembled, bracelet.

Fabricated from 9 carat yellow gold.

Of a round-shape 'belcher' style linkage in an alternating plain and engraved design.

Linkage of hollow construction.

Medium-size filigree style, 'padlock' type clasp attached.

Ring style end link sections.

Polished finish.

Stamped '9CT' (on bracelet), '375' (on padlock).

Acid tested as 9 carat gold.

Bracelet dimensions = 18.00cm (length including end sections) x 7.75mm (ave. diameter).

Padlock dimensions = 24.00mm (length including arm) x 18.00mm (width) x 5.74mm (depth).

Total Item Weight = 18.06 grams.
