Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, dress style ring, of cast construction.

Plain, narrow, tapered band of 1.97mm in width (at base) x 1.00mm depth, with open back centre settings, and hollow, open back shoulder settings.

Feature three Princess cut diamonds, channel set between the 'cross-over' style shoulders, of the plain and polished band. Each shoulder having thirteen round brilliant cut diamonds, shared bead set. Rhodium plating to the setting areas.

Polished finish - stamped '750 CG' - acid tested as 18 carat gold. Finger size is O.

The ring contains:

Three channel set Princess cut diamonds, clarity 'Si', colour 'G'.

Dimensions = 3.00mm(L) x 2.95mm(W) x 2.55mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.56ct (estimated - see NOTE below)

Twenty Six bead set round brilliant cut diamonds, clarity 'Si', colour 'H to I' (mixed).

Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.44ct (estimated - see NOTE below)

Total Item Weight = 4.48 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
