Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, cluster style, gem set, dress ring.

Plain, narrow band of 2.45mm in width (at base) x 1.09mm depth, with a curved underrail.

Feature four claw setting, consisting of an illusion plate, housing one round brilliant cut diamond, sunken set to the centre. Surrounded by eight round brilliant cut diamonds, triangular claw set. All secured between the extended and pointed shoulders of the plain and polished band.

Polished finish - stamped '750 Ci 0410 Rosalia 1.8' - acid tested as 18 carat gold. Finger size is K 1/2.

The ring contains:

One sunken set round brilliant cut diamond, clarity 'Vs', colour 'G'.

Dimensions = 3.87mm(Dia) x 2.36mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Eight illusion claw set round brilliant cut diamonds, clarity 'Vs', colour 'G'.

Dimensions (average) = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.26 grams - Total Gemstone Weight = 0.41ct - Total Metal Weight = 3.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
