Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.69mm width (at base) x 0.98mm depth, with a curved underrail.

Feature 'pagoda' style ring, with a central white gold square top plate, housing nine single cut diamonds, claw set. Each of the shoulders houses one row of three single cut diamonds, claw set. The settings are secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped 'illegible stamps PAM WD' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

Fifteen claw set single cut diamonds, clarity is "Vs", colour is "G to H" (mixed).

Dimensions = 1.40mm(diameter) (smallest)

Dimensions = 1.90mm(diameter) (largest)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 6.04 grams

Total Gemstone Weight = 0.32ct

Total Metal Weight = 5.98 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
