Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered, narrow, tapered band of 1.85mm in width (at base) x 0.73mm depth, with a curved, split and open underrail.

Feature central four claw setting, housing one oval-shape cabochon cut treated jadeite type material, claw set. The decorative surround and shoulders, of the plain and polished band, having a total of one hundred and sixty-eight round cut diamonds, varying in size, also claw set.

Polished finish - stamped 'G18K' - acid tested as 18 carat gold. Finger size is K.

The ring contains:

One claw set round-shape cabochon cut treated jadeite type material.
Dimensions = 7.80mm(ave. dia) x 1.95mm(D-estimated)

One Hundred And Sixty Eight claw set single cut(76) & round brilliant cut (16) diamonds, clarity 'Vs & Si' (mixed), colour 'H'.
Dimensions = 0.60mm to 1.30mm (diameter)
Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.01 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
