Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, multistone, gem set, dress style ring, of cast construction.

Plain, narrow, reverse tapered band of 2.54mm in width (at base) x 1.40mm depth, with open back settings.

Feature central two 'V' claw railed setting, housing one marquise cut sapphire, claw set. To either side is one round brilliant cut diamond, three claw set. All secured between the 'ramp' style shoulders of the plain and polished band.

Polished finish.

Stamped '750 with diamond symbol' - acid tested as 18 carat gold. Finger size is M 1/2.

The ring contains:

One claw set mixed cut marquise natural sapphire, colour 'medium dark blue'.
Dimensions = 10.12mm(L) x 4.84mm(W) x 3.20mm(D-estimated)
Total Weight = 1.05ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed).
Dimensions (average) = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 3.60 grams - Total Gemstone Weight = 1.12ct - Total Metal Weight = 3.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
