Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round band of 2.32mm width (at base) x 1.13mm depth, with a hollow top and shoulders, and a cut out curved underrail.

Feature one diagonal row of three round brilliant cut diamonds, channel set. The settings are framed with a decorative groove that runs down the shoulders, and is secured between the tapering shoulders, of the plain and polished band. Rhodium plating to the diamond setting area.

Polished finish.

Stamped '9K(faint)' - acid tested as 9 carat gold.

Ring size: U.

The ring contains:

Three channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 4.04 grams

Total Gemstone Weight = 0.14ct

Total Metal Weight = 4.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
