Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished / cast raised, 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.92mm width (at base) x 1.01mm depth, with cut-out underrail, open back settings underneath. Feature, 'cluster style' ring design, with shoulder stones. Comprising, a rectangular shaped setting to top, houses five baguette cut diamonds & four round brilliant cut diamonds (grouped together), channel & bead set (mixed), Drops to a surround, containing eighteen round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up, splits & crosses over, each shoulder contains fourteen baguette cut diamonds (total x 28), channel set both sides.



Polished finish, stamped "9, .50ct (partial & faded)" - acid tested as 9 carat gold. Finger size = S.

The ring contains;

Five channel set baguette cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Ave dimensions = 1.50mm (L) x 1.00mm (W) x 0.73mm (D-estimated) (smallest)
Ave dimensions = 2.00mm (L) x 1.00mm (W) x 0.73mm (D-estimated) (largest)
Total Weight = 0.08ct (estimated - see NOTE below).

Twenty Eight channel set baguette diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.
Ave dimensions = 1.00mm (L) x 0.80mm (W) x 0.58mm (D-estimated) (smallest)
Ave dimensions = 1.50mm (L) x 1.00mm (W) x 0.73mm (D-estimated) (largest)
Total Weight = 0.25ct (estimated - see NOTE below).

Twenty Two bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.20mm (ave diameter) x 0.73mm (D-estimated) (smallest)
Dimensions = 1.50mm (ave diameter) x 0.92mm (D-estimated) (largest)
Total Weight = 0.27ct (estimated - see NOTE below).

Total Item Weight = 3.51 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 3.39 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
