Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat band of 3.11mm width (at base) x 0.83mm depth, with a curved underrail.

Feature central white gold four claw setting, housing one rectangle cut natural sapphire, claw set. Surrounding is one row of fourteen claw settings, each housing one single cut diamond, varying in size, claw set. The settings are secured to the underrail, and in between the tapering shoulders, of the plain and polished yellow gold band. The shoulders have been finished with a 'bark' style texture.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

One claw set rectangular natural sapphire, colour is "blue".

Dimensions = 5.83mm(L) x 4.35mm(W) x 2.65mm(D-estimated)

Total Weight = 0.66ct (estimated - see NOTE below)

Fourteen claw set single cut diamonds, clarity is "Vs", colour is "H to J" (mixed).

Dimensions = 1.40mm (diameter) (smallest)

Dimensions = 1.60mm (diameter) (largest)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 4.66 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 4.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
