Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.10mm width (at base) x 0.85mm depth, with open back settings, and a curved underrail.

Feature central white gold four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders houses one row of four Princess cut diamonds, channel set.



Polished finish.

Stamped '18K NOC' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set Princess cut diamond, clarity is "Si1", colour is "G".

Dimensions = 4.43mm(L) x 4.35mm(W) x 3.09mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 3.77 grams Total Gemstone Weight = 0.82ct Total Metal Weight = 3.61 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
