Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.52mm width (at base) x 1.33mm depth, with a curved underrail.

Feature central three claw setting, housing one pear shaped diamond, claw set. The double surround, gallery, and shoulders house a total of eighty-three round brilliant cut diamonds, all claw set. The gallery has been embellished with two bezel settings, each housing one round ruby, bezel set. The top plate is secured to the underrail and in between the extended and square shoulders, of the plain and polished band.



Polished finish. Stamped '14K Sir Michael Hill 400913030 0.87' - acid tested as 14 carat gold. Ring size: N.

The ring contains:

One claw set pear shaped diamond, clarity is "P1", colour is "E".

Dimensions = 5.79mm(L) x 3.90mm(W) x 2.38mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Eighty Three claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Two bezel set round rubies, colour is "red".

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 3.27 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 3.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
